

RESOLUTION NO. 2005 - 282

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, PETITIONING THE NEW JERSEY COUNCIL ON AFFORDABLE HOUSING: (FOR SUBSTANTIVE CERTIFICATION OF ITS HOUSING ELEMENT AND FAIR SHARE PLAN)

WHEREAS, the Planning Board of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, adopted the Housing Element of the Master Plan on December 1, 2005; and

WHEREAS, a true copy of the resolution of the Planning Board adopting the Housing Element is attached pursuant to N.J.A.C. 5:95-2.2(a)2; and

WHEREAS, the Planning Board adopted the Fair Share Plan on December 1, 2005; and

WHEREAS, a true copy of the resolution of the Planning Board adopting the Fair Share Plan is attached pursuant to N.J.A.C. 5:95-2.2(a)2.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, hereby endorses the Housing Element and Fair Share Plan as adopted by the Little Egg Harbor Planning Board.

2. That the governing body of the Township of Little Egg Harbor, pursuant to the provisions of N.J.S.A. 52:27D-301 et seq. and N.J.A.C. 5:95-3.2, submits this petition for substantive certification of the Housing Element and Fair Share Plan to the Council on Affordable Housing for review and certification.


4. That all owners of sites in the Housing Element and Fair Share Plan have received notice of this petition.

5. That a notice of this Petition for Substantive Certification shall be published in a newspaper of countywide circulation pursuant to N.J.A.C. 5:95-3.5 within seven (7) days of issuance of the notification letter from the Council on Affordable Housing's Executive Director indicating that the submission is complete and that a copy of this resolution, the adopted Housing Element and Fair Share Plan and all supporting documentation, shall be made available for public inspection at the Township of Little Egg Harbor Municipal Clerk's office located at 665 Radio Road, during the hours of 8:30 a.m. and 4:30 p.m. on Monday through Friday for a period of forty-five (45) days following the date of publication of the legal notice pursuant to N.J.A.C. 5:95-3.5.

6. That a certified copy of this resolution shall be forwarded to the Township Planner and the Council on Affordable Housing.


