**LITTLE EGG HARBOR TOWNSHIP PLANNING BOARD**  
**RESOLUTION ADOPTING THE JUNE 2017 AMENDMENT TO**  
**THE HOUSING ELEMENT AND FAIR SHARE PLAN OF THE**  
**LITTLE EGG HARBOR TOWNSHIP MASTER PLAN**

**WHEREAS**, the Planning Board of Little Egg Harbor Township, Ocean County, State of New Jersey, adopted its current Master Plan Reexamination Report pursuant to N.J.S.A. 40:55D-89 in 2015; and

**WHEREAS**, the Little Egg Harbor Township Planning Board previously prepared a Housing Element and Fair Share Plan pursuant to N.J.S.A. 40:55D-28(b)(3), which has been duly approved and adopted by the Board; and

**WHEREAS**, the Little Egg Harbor Township Planning Board is now considering an Amendment to the Housing Element and Fair Share Plan, dated June 2017, amending the previously approved and adopted Housing Element and Fair Share Plan; and

**WHEREAS**, upon notice duly provided pursuant to N.J.S.A. 40:55D-13, the Planning Board of Little Egg Harbor Township held a public hearing on the Amendment to the Housing Plan Element and Fair Share Plan on July 6, 2017; and

**WHEREAS**, the Planning Board has determined that the June 2017 proposed Amendment to the Housing Plan Element and Fair Share Plan is consistent with the goals and objectives of the Little Egg Harbor Township Master Plan Reexamination Report and that adoption and implementation of said Amendment to the Housing Plan Element and Fair Share Plan is in the public interest and protect public health and safety and promote the general welfare.

**NOW THEREFORE BE IT RESOLVED**, by the Planning Board of Little Egg Harbor Township, in the County of Ocean, State of New Jersey, that the Planning Board hereby approves and adopts the June 2017 Amendment to the Housing Plan Element and Fair Share Plan.

**BE IT FURTHER RESOLVED** that copies of this resolution and said Amendment to the Housing Plan Element and Fair Share Plan shall be filed with the Little Egg Harbor Township Clerk, the Ocean County Planning Board, the Pinelands Commission and the municipal clerk of all adjoining municipalities.
