

**RESOLUTION NO. 2016-110**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE APPOINTMENT OF TWO FULL-TIME LABORERS TO THE DEPARTMENT OF PUBLIC WORKS**

**WHEREAS**, at the April 14, 2016 meeting of the Township Committee, the Committee adopted a Resolution authorizing the Administrator to interview potential laborers for the Department of Public Works; and

**WHEREAS**, the Township Administrator has recommended Grant J. Carey, who has a CDL license and Donald V. Russell to the Township Committee; and

**WHEREAS**, the governing body has determined that it is in the best interests of the Township to hire Grant J. Carey and Donald V. Russell as full-time laborers for the Department of Public Works; and

**WHEREAS**, the salary for Grant J. Carey shall be \$16.85 an hour, and the salary for Donald J. Russell shall be \$15.85 an hour and said length of employment shall be as directed by the New Jersey Civil Service Commission, Department of Personnel.

**NOW, THEREFORE, BE IT RESOLVED**, that the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That Grant J. Carey is hereby appointed as a full-time laborer for the Township of Little Egg Harbor Public Works Department at a salary of \$16.85 an hour, in accordance with the Township Salary Ordinance.

2. That Donald V. Russell is hereby appointed as a full-time laborer for the Township of Little Egg Harbor Public Works Department at a salary of \$15.85 an hour, in accordance with the Township Salary Ordinance.

3. That these appointments shall be effective on April 29, 2016.

4. That said appointments are expressly contingent upon the completion of a background check. If the background checks are satisfactory, the Township Administrator shall issue to the governing body a written memorandum on the date of the favorable background check report. Under no circumstances shall the named individuals be considered employees of Little Egg Harbor Township unless and until the above conditions are satisfied..

5. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to Grant J. Carey and Donald V. Russell.
