**RESOLUTION OF THE TOWNSHIP OF LITTLE
EGG HARBOR, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AUTHORIZING THE SUBMISSION
OF AN APPLICATION FOR THE 2016
RECREATIONAL TRAILS PROGRAM GRANT**

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres Program (“State”), provides grants to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition and development of lands for outdoor recreation and conservation purposes; and

WHEREAS, the Township of Little Egg Harbor desires to further the public interest by obtaining funding in the amount of \$24,000 from the State to fund the following project: “2016 Recreation Trails Grant – Trail Enhancements at the Township Recreation Complex” at a total cost of \$62,150.00;

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- (a) That the Township Engineer is hereby authorized to make application for such a grant,
- (b) That the Township and/or Township Engineer shall provide additional application information and furnish such documents as may be required, and
- (c) That the Township Engineer shall act as the authorized correspondent for the Township.

WHEREAS, the State shall determine if the application is complete and in conformance with the scope and intent of the Recreational Trails Program, and notify the Township of the amount of the funding award; and

WHEREAS, the Township is willing to use the State’s funds in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the State for the above named project;

NOW, THEREFORE, BE IT FURTHER RESOLVED by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey:

1. That the Mayor is hereby authorized to execute and the Township Clerk to attest to an agreement and any amendment thereto with the State known as "2016 Recreation Trails Grant – Trail Enhancements at the Township Recreation Complex";
2. That the Township has its matching share of the project, if a match is required, in the amount of \$38,150.00;
3. That, in the event the State's funds are less than the total project cost specified above, the Township has the balance of funding necessary to complete the project;
4. That the Township agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project; and
5. That the Township Clerk is directed to forward a certified copy of this Resolution to the Township Engineer and to the New Jersey Department of Environmental Protection, Green Acres Program.
