**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG  
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY  
AUTHORIZING THE RENEWAL OF PLENARY RETAIL  
CONSUMPTION AND PLENARY RETAIL DISTRIBUTION
