

RESOLUTION NO. 2016 – 148

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE INTERVIEW AND HIRING OF TWO (2) POLICE OFFICERS

WHEREAS, the Township of Little Egg Harbor Police Department requires the appointment of two Police Officers; and

WHEREAS, potential Police Officers must be offered employment and must accept said offer of employment prior to the Township conducting the necessary background check, and a process of physical and mental evaluation; and

WHEREAS, Police Chief Richard Buzby has requested that he be afforded the opportunity to interview, hire and evaluate potential police officers prior to their names being made public; and

WHEREAS, the Township Committee wishes to authorize Police Chief Richard Buzby to interview and hire two police officers at salaries in accordance with the Collective Bargaining Agreement between the Township of Little Egg Harbor and the Policeman's Benevolent Association, Local 295 and the Township Salary Ordinance; and

WHEREAS, the Township Committee will adopt a resolution appointing the police officers following their successful completion of the evaluation process and to confirm the appointment of the Police Officers which will be effective upon their swearing in.

NOW, THEREFORE, BE IT RESOLVED, that the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That Police Chief Richard Buzby is hereby authorized to interview and hire two police officers for the Township of Little Egg Harbor Police Department, at an annual

salary in accordance with the Collective Bargaining Agreement between the Township of Little Egg Harbor and the Policeman's Benevolent Association, Local 295 and the Township Salary Ordinance.

2. That said appointments shall be effective upon the date of the Officers' swearing in and the administration of the Oath of Office.
3. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Township Administrator and the Chief of Police.
