

**RESOLUTION NO. 2016 - 15**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING GEORGE GARBARAVAGE OF ANIMAL CAPTURE & CONTROL SERVICES AS ANIMAL CONTROL OFFICER FOR THE TOWNSHIP OF LITTLE EGG HARBOR**

**WHEREAS**, the Township of Little Egg Harbor is in need of Animal Control Services; and

**WHEREAS**, although the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*, authorizes the award of contracts for “Professional Services” without competitive bids, the Township issued a request for proposals for professional service contracts in accordance with the competitive negotiation procedure as delineated within Section 40-8 of the Township Code of the Township of Little Egg Harbor, entitled “Fair and open process utilized to award contracts with anticipated value in excess of \$17,500”; and

**WHEREAS**, a determination of value has been made by the Township that said contract shall be a value in excess of \$17,500; and

**WHEREAS**, said competitive negotiation procedure satisfies the requirements of a fair and open process under N.J.S.A. 19:44A:20.2 *et seq.*; and

**WHEREAS**, all proposals were to be submitted to the Office of the Township Clerk by December 1, 2015; and

**WHEREAS**, the Township Administrator has reviewed the proposals submitted and recommends George Garbaravage of Animal Capture & Control Services; and

**WHEREAS**, George Garbaravage of Animal Capture & Control Services is duly qualified to provide Animal Control Services; and

**WHEREAS**, it is the desire of the Mayor and Township Committee to appoint George Garbaravage of Animal Capture & Control Services as Animal Control Officer for the Township of Little Egg Harbor; and

**WHEREAS**, the maximum amount of the contract to be awarded under this resolution is set forth in the 2016 municipal budget; and

**WHEREAS**, the Chief Financial Officer has certified that there are funds available for this contract, which certification is annexed hereto; and

**WHEREAS**, the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*, authorizes the award of contracts for “Professional Services” and requires that the resolution and contract be made available for public inspection.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows;

1. That George Garbaravage of Animal Capture & Control Services is hereby appointed as Animal Control Officer for the Township of Little Egg Harbor for a term of one year, commencing January 1, 2016 and ending December 31, 2016 at a monthly fee of \$3,249.00 not to exceed and annual amount of \$38,988.00.

2. That the Mayor is hereby authorized to execute and the Township Clerk to attest to the attached agreement with George Garbaravage of Animal Capture & Control Services.

3. That this contract is awarded as a “Professional Service” in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law because it is for services to be performed by a person(s) authorized by law to practice a recognized profession.

4. That a notice of this action shall be printed once in the official newspaper of the Township of Little Egg Harbor.

5. That this resolution shall take effect on January 1, 2016.

6. That the agreement shall be an open ended contract with funds being encumbered contingent upon the availability of funds in the budget year. No services shall be rendered under the contract until the Chief Financial Officer has certified the availability of funds for such services.

7. That a certified copy of this resolution, together with a copy of the contract between the parties, shall be provided by the Township Clerk to the Chief Financial Officer, and George Garbaravage of Animal Capture & Control Services.
