**RESOLUTION OF THE TOWNSHIP OF LITTLE
EGG HARBOR, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AWARDING AN AGREEMENT TO
S. BATATA CONSTRUCTION FOR THE 2015
STREETSCAPE IMPROVEMENT PROJECT**

WHEREAS, pursuant to N.J.S.A. 40A:11-1 et seq., the Township of Little Egg Harbor duly advertised for bids for the 2015 Streetscape Improvement Project; and

WHEREAS, in response to the invitation to bidders, four (4) bids were received on June 24, 2016; and

WHEREAS, the bid was separated into six difference components, the Base Bid and Alternate Bids "A" through "E"; and

WHEREAS, the bids have been reviewed by the Township Engineer, the Township Administrator and the Township Attorney and it has been determined that the bid submitted by S. Batata Construction of Parlin, New Jersey is the lowest responsible bid in accordance with the bid specifications, said bid being \$732,679.00 for the Base Bid and \$11,050.00 for Alternate Bid "D"; and

WHEREAS, it is the desire of the governing body to award a contract for the 2015 Streetscape Improvement Project to S. Batata Construction, for the Base Bid and Alternate Bid "D".

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That S. Batata Construction is hereby awarded the contract for the 2015 Streetscape Improvement Project for the performance of the Base Bid and Alternate Bid "D."

2. That the Mayor is hereby authorized to execute and the Township Clerk to attest to a Contract with S. Batata Construction consistent with that company's bid submission, attached hereto as Schedule A, and subject to the approval of the Township Attorney.

3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the 2015 Streetscape Improvement Project.

4. That a certificate of availability of funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract: G-02-40-365-110

5. That a certified copy of this resolution, together with a copy of the contract between the parties, shall be provided by the Municipal Clerk to the Chief Financial Officer, the Township Engineer and S. Batata Construction.


