

RESOLUTION NO. 2016-158

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY,
CANCELING TAXES AND AUTHORIZING A REFUND
PURSUANT TO N.J.S.A. 54:4-3.30**

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that the property located at Block 285.06, Lot 22 owned by Richard Samalonis qualifies for a Veteran's Property Tax Exemption; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally disabled veterans portion of the 2016 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

WHEREAS, in this case the Tax Collector deems that the Homeowner should receive a refund on taxes already paid for the year 2016:


