RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, PROVIDING DATES FOR TOWNSHIP COMMITTEE MEETINGS AND DESIGNATING OFFICIAL NEWSPAPERS FOR THE YEAR 2016

WHEREAS, the Open Public Meetings Act of 1976 requires public bodies to provide notice of all meetings in an effort to enhance the proper functioning of the Democratic process; and

4. A copy of this resolution shall be filed with the Municipal Clerk of the Township of Little Egg Harbor.
