

**RESOLUTION NO. 2016-182**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A CHANGE ORDER TO THE CONTRACT WITH T&M ASSOCIATES FOR THE NFWF MARSH RESTORATION PROJECT**

**WHEREAS**, a contract was previously awarded to T&M Associates for the NFWF Marsh Restoration Project; and

**WHEREAS**, the original contract for said improvements was in the amount of \$309,310.00 and was increased by \$351,528.00 by Change Orders No. 1, 2 and 3; and

**WHEREAS**, the governing body wishes to authorize Change Order No. 4, which will result in an increase in \$23,240.00 in the contract price, consisting in an increase for a hydrographic survey, collection of sediment cores, sample analysis and dredge design; and

**WHEREAS**, the additional funds necessary for the change order come from the NFWF Grant and are not taxpayer funded; and

**WHEREAS**, it is the desire of the governing body to authorize the execution of this change order.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of Change Order No. 4 adjusting the contract with T&M Associates for the NFWF Marsh Restoration Project which will result in an increase of \$23,240.00 in the contract price, consisting in an increase for a hydrographic survey, collection of sediment cores, sample analysis and dredge design.

2. That Change Order Number 4 increases the total contract amount to \$684,078.00.

3. That the Mayor is hereby authorized to execute and the Township Clerk to attest to an addendum to the contract with T&M Associates in accordance with the provisions of this resolution.

4. That a certified copy of this resolution, together with a copy of Change Order No. 4, be forwarded to the Chief Financial Officer and T&M Associates.
