**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE PROCUREMENT OF THREE IN-VEHICLE POLICE RADIOS**

**WHEREAS**, the Township of Little Egg Harbor Police Department requires a three police radios for installation in police vehicles to ensure the continuation of essential services to the Township; and

**WHEREAS**, the Police Department wishes to purchase the radios as follows from Allcom Technologies, Inc. through the New Jersey State Contract No. 83902:
