**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG  
HARBOR, COUNTY OF OCEAN, STATE OF NEW  
JERSEY, APPOINTING MEMBERS TO THE LITTLE  
EGG HARBOR TOWNSHIP PLANNING BOARD**

**WHEREAS**, the Township of Little Egg Harbor has determined that there is a need for appointments to the Township Planning Board; and

**WHEREAS**, N.J.S.A. 40:55D-23 provides that the membership of the Planning Board shall consist of Class I, Class II, Class III and Class IV appointees.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the Mayor is hereby appointed as the Class I member of the Little Egg Harbor Township Planning Board for a term of one year. Said term shall commence on January 1, 2016 and expire on December 31, 2016.

2. That George Sauer is hereby appointed as the Class II member of the Little Egg Harbor Township Planning Board for a term of one year. Said term shall commence on January 1, 2016 and expire on December 31, 2016.

3. That a Committee Member is hereby appointed as the Class III member of the Little Egg Harbor Township Planning Board for a term of one year. Said term shall commence on January 1, 2016 and expire on December 31, 2016.

4. That Kenneth Laney is hereby appointed as a Class IV member of the Little Egg Harbor Township Planning Board for a four-year term. Said term shall commence on January 1, 2016 and expire on December 31, 2019.

5. That Ann McDonald is hereby appointed as a Class IV member of the Little Egg Harbor Township Planning Board for the unexpired term of Ken Miller. Said term shall commence on January 1, 2016 and expire on December 31, 2018.

6. That Edward Andrews is hereby appointed as Alternate Member No. 1 of the Little Egg Harbor Township Planning Board for a two year term. Said term shall commence on January 1, 2016 and expire on December 31, 2017.
