

**RESOLUTION NO. 2016 - 56**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE FILING OF AN APPLICATION WITH THE NEW JERSEY DIVISION OF CRIMINAL JUSTICE FOR THE SAFE AND SECURE COMMUNITIES GRANT PROGRAM**

**WHEREAS**, it is the desire of the Township of Little Egg Harbor to file an application with the New Jersey Department of Law and Public Safety, Division of Criminal Justice for the FY 2016 Safe and Secure Communities Grant Program, authorized by N.J.S.A. 52:17B-159 *et seq*; and

**WHEREAS**, the Safe and Secure Communities Program is designed to provide municipalities with funding to add law enforcement personnel vital to effective police operations and other crime-related strategies as warranted by the needs of the community; and

**WHEREAS**, the Township Committee desires to authorize the Chief of Police to execute and submit the Safe and Secure Communities Grant Program Application, together with all other supporting documentation, to the New Jersey Department of Law and Public Safety, Division of Criminal Justice.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby authorize the filing of an application with the New Jersey Department of Law and Public Safety, Division of Criminal Justice for the Safe and Secure Communities Grant Program.

2. That the governing body does hereby designate the Chief of Police as the individual responsible and authorized by the governing body to execute and submit the Safe and Secure Communities Grant application, together with all other supporting documentation,

to the New Jersey Department of Law and Public Safety, Division of Criminal Justice for the above-referenced project.

3. That upon the adoption of this resolution the Township Clerk is authorized and directed to forward a certified copy of said resolution to the Chief of Police and the New Jersey Department of Law and Public Safety.
