

**RESOLUTION NO. 2016 – 78**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG  
HARBOR, COUNTY OF OCEAN, STATE OF NEW  
JERSEY, AMENDING RESOLUTION 2016-70**

**WHEREAS**, on February 25, 2016 the Township Committee adopted Resolution 2016-70 appointing two new police officers to the Police Department of the Township of Little Egg Harbor Police Department; and

**WHEREAS**, one of the appointed Officers has declined the position with the Township of Little Egg Harbor; and

**WHEREAS**, John J. Covone shall be appointed as a Police Officer instead of Michael LaMontagne; and

**WHEREAS**, the Township Committee wishes to amend Resolution 2016-70 to change the name of the appointed Police Officers; the salary and appointment dates remain unchanged; and

**WHEREAS**, the Township Committee wishes to confirm the appointment of John J. Covone and Matthew Cook as Police Officers for the Township of Little Egg Harbor, effective upon their swearing in.

**NOW, THEREFORE, BE IT RESOLVED**, that the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:


1. That John J. Covone is appointed as a Police Officer for the Township of Little Egg Harbor Police Department, at an annual salary of \$43,064.00 in accordance with the Collective Bargaining Agreement between the Township of Little Egg Harbor and the Policeman's Benevolent Association, Local 295 and the Township Salary Ordinance.

2. That Matthew Cook is appointed as a Police Officer for the Township of Little Egg Harbor Police Department, at an annual salary of \$43,064.00 in accordance with the Collective Bargaining Agreement between the Township of Little Egg Harbor and the Policeman's Benevolent Association, Local 295 and the Township Salary Ordinance.
3. That said appointments shall be effective upon the date of the Officers' swearing in and the administration of the Oath of Office.
4. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Township Administrator, the Chief of Police, John J. Covone and Matthew Cook.
