

RESOLUTION NO. 2017 – 148

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, REQUEST TO THE WAIVE ROAD OPENING PERMITS FEES FOR TWIN LAKES PROJECT FOR THE COMPLETE RESTORATION OF TWIN LAKES BOULEVARD

WHEREAS, the complete restoration of Twin Lakes Boulevard is the single largest project undertaken by the Little Egg Harbor Municipal Utilities Authority (Authority); to complete total restoration of all water and sewer infrastructure including water and sewer service connections; and

WHEREAS, the Township of Little Egg Harbor (Township) is looking to reduce overall costs to the rate payers and the tax payers of the Township; and

WHEREAS, the Executive Director of the MUA has requested waiver of all road opening permit fees for this project and future road openings in the Township where work is being performed by, or for the Authority; and

WHEREAS, the Authority has provided copies of survey work performed and paid for by the Authority so that the Township would not have to pay for this work again as a cost saving measure; and

WHEREAS, the Authority has waived water and sewer connection fees for the Township properties as a cost saving measure; and

WHEREAS, the Authority does not bill the Township for quarterly water and sewer charges or for fire hydrant services as a cost saving measure; and

WHEREAS, the examples provided are only a few procedures the Authority does at no cost to the Township for which they are glad to do so; and

WHEREAS, work is scheduled to begin on June 12th, 2017 and and the last requirement is the road opening permit that the Executive Director of the Township is requesting to waive the road opening permit fee to benefit customers and residents of the Township.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body authorizes the waiver of the road opening permit that is being requested for the Twin Lakes Project to reduce overall costs to the rate payers and the tax payers of the Township.
2. That the Mayor is authorized to execute and the Township Clerk to attest to any and all documentation required for the submission of said application to authorize the request for the road opening permit waiver.
3. That a certified copy of this resolution shall be forwarded to the Municipal Utilities Authority.
