

**RESOLUTION NO. 2017 – 187**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A COLLECTIVE BARGAINING AGREEMENT AND THE RATIFICATION OF A MEMORANDUM OF AGREEMENT WITH AFSCME COUNCIL 963 (WHITE COLLAR)**

**WHEREAS**, the negotiation committees of the Township of Little Harbor and the AFSCME Council 963 (White Collar) met and negotiated terms and conditions of employment for certain employees of Little Egg Harbor Township; and

**WHEREAS**, the parties have come to an agreement with regard to the terms and conditions of the collective bargaining agreement; and

**WHEREAS**, the parties have entered into a Memorandum of Agreement dated August 9, 2017, with regard to said terms and conditions of employment for the period of time between January 1, 2016, and December 31, 2019; and

**WHEREAS**, the governing body wishes to ratify the Memorandum of Agreement dated August 9, 2017, and authorize the execution of a collective bargaining agreement with the AFSCME Council 963 (White Collar) incorporating the terms of the Memorandum of Agreement in a form acceptable to the Township's Labor Counsel.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body hereby ratifies the Memorandum of Agreement, dated August 9, 2017, between the negotiating committee of the Township of Little Egg Harbor and the negotiating committee of the AFSCME Council 963 (White Collar) with regard to the terms and conditions of employment.

2. That the Mayor is hereby authorized to execute and the Township Clerk to attest to, respectively, a collective bargaining agreement between the Township and the AFSCME Council 963, incorporating the terms of the Memorandum of Agreement in a form acceptable to the Township's Labor Counsel.

3. That this resolution shall take effect immediately.

4. That a certified copy of this resolution shall be forwarded to the AFSCME Council 963 (White Collar), E. David Millard, Esq. and the Chief Financial Officer.
