

RESOLUTION NO. 2024-266

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE PREPARATION OF SPECIFICATIONS FOR THREE (3), 2023 OR NEWER, POLICE PATROL SPORT UTILITY VEHICLES FOR USE BY THE POLICE DEPARTMENT AND FURTHER AUTHORIZING THE RECEIPT OF BIDS FOR SAME

WHEREAS, the Township is in need of three (3), 2023 or newer police patrol sport utility vehicles (SUV's) for the Little Egg Harbor Police Department; and

WHEREAS, the anticipated cost for three (3), 2023 or newer, police patrol sport utility vehicles (SUV's) is expected to exceed \$44,000.00 (QPA bid threshold) so as to require public bidding in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, it is the desire of the governing body to advertise for and receive bids for three (3), police patrol sport utility vehicles (SUV's), model year 2023 or newer, and to further authorize the Township Administrator and/or other appropriate personnel to prepare the bid specifications for the receipt of bids for three (3), 2023 or newer, police patrol sport utility vehicles (SUV's).

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the preparation of specifications, and the subsequent receipt of bids for three (3), 2023 or newer, police patrol sport utility vehicles (SUV's) for use by the Police Department. The Township shall determine the time, date and place for the receipt of said bids.

2. That the Township Administrator and/or appropriate personnel are hereby authorized to prepare the bid specifications for the receipt of bids for three (3), 2023 or newer, police patrol sport utility vehicles (SUV's).

3. That a notice to bidders shall be published in regard to the receipt of bids for three (3), 2023 or newer, police patrol sport utility vehicles (SUV's), in accordance with the specifications prepared by the Township Administrator and/or appropriate personnel.

4. That a certified copy of this resolution shall be forwarded to the Qualified Purchasing Agent, Township Administrator/Chief Financial Officer, and the Chief of Police.
