

**ORDINANCE 2024-32**

**AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 144 OF THE TOWNSHIP CODE ENTITLED “BUILDING MATERIAL DROPOFF”**

**NOW, THEREFORE, BE IT ORDAINED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** That the governing body hereby amends and supplements Chapter 144 of the Township Code entitled “Building Material Dropoff” so as to amend §144-1, “Township dropoff center for residents only; dropoff regulations”, Subsection A as follows:

**§ 144-1 Township dropoff center for residents only; dropoff regulations.**

- A.** The Township of Little Egg Harbor maintains a dropoff center at the Department of Public Works facility for the convenience of Township residents for the disposition of Minor Building Materials, as defined in Chapter 293, Section 293-3. Said dropoff center is for the use of residents of Little Egg Harbor Township for disposition of Minor Building Materials generated by their personal use only.

**SECTION 2.** That the governing body hereby amends and supplements Chapter 144 of the Township Code entitled “Building Material Dropoff” so as to amend §144-2, “Township dropoff center for residents only; dropoff regulations”, Subsection E as follows:

**§ 144-1 Township dropoff center for residents only; dropoff regulations.**

- E.** Residents shall be limited to a total of six drop-offs in a calendar year, and each dropoff is limited to no more material than is equivalent to twice the amount of what would fit into a Township-provided automated trash container with the cover fully closed. In other words, the amount of Minor Building Materials that may be dropped off is what would fit in two

(2) Township-provided automated trash containers with the cover fully closed. If a resident chooses pick up of Minor Building Materials as delineated in Chapter 293, the amount is limited to one (1) Township-provided automated trash container with the cover fully closed.

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
