

RESOLUTION NO. 2024-278

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (JOHN F. BOWERSOX, BLOCK 282, LOT 6.13)

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 282, Lot 6.13, owned by John F. Bowersox, qualified for a Veterans' Property Tax Exemption in the year 2024; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes and remove the added/omitted from the 2024 tax sale list, in the amount of \$1,302.70; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2024 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and


NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes and remove the added/omitted from the 2024 tax sale list, in the amount of \$1,302.70 for Block 282, Lot 6.13, owned by John F. Bowersox.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, John F. Bowersox and the Chief Financial Officer.

TOTALLY DISABLED VETERAN
ASSESSMENT CREDIT WORKSHEET



WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2024 based upon a prorated assessment of \$229,300 applied by the F01 Tax Rate, taxes outstanding that would otherwise be exempt.
