

**RESOLUTION NO. 2025-061**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (DANIEL HEBERT, BLOCK 325.60, LOT 30)**

**WHEREAS, N.J.S.A. 54:4-3.30** provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

**WHEREAS,** it has been determined by the Tax Assessor that property known as Block 325.60, Lot 30, owned by Daniel Hebert, qualified for a Veterans' Property Tax Exemption in the year 2024; and

**WHEREAS,** the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

**WHEREAS,** the Tax Collector has requested authorization to cancel property taxes, in the amount of \$350.37; and

**WHEREAS,** pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2024 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

**WHEREAS,** the Tax Collector deems that the Mortgage Company, Corelogic, receive a refund on taxes already paid for the year 2024 in the amount of \$350.37; and

**WHEREAS,** the Tax Collector deems that the Title Company, Surety Title, receive a refund on taxes already paid for the year 2024 in the amount of \$1,065.72.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$350.37 for the year 2024 for Block 325.60, Lot 30, owned by Daniel Hebert and authorize a refund to Corelogic, in the amount of \$350.37 and Surety Title in the amount of \$1,065.72.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Daniel Hebert, Corelogic, Surety Title and the Chief Financial Officer.
