RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE STATE OF NEW JERSEY, DEPARTMENT OF COMMUNITY AFFAIRS, REQUESTING FY 2025 LOCAL RECREATION IMPROVEMENT GRANT IN THE AMOUNT OF \$100,000 FOR IMPROVEMENTS TO LITTLE TREASURES PARK

WHEREAS, the Township of Little Egg Harbor desires to apply for and obtain a Local Recreation Improvement Grant from the State of New Jersey, Department of Community Affairs in the amount of \$100,000.00 for improvements to Little Treasures Park including the resurfacing of the basketball courts and upgrades to the softball fields; and

WHEREAS, the governing body desires to authorize the Township Engineer to submit an application to the State of New Jersey, Department of Community Affairs for a \$100,000.00 FY2025 Local Recreation Improvement Grant for improvements to Little Treasures Park.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the submission of an application to the State of New Jersey, Department of Community Affairs for a \$100,000.00 Local Recreation Improvement Grant for improvements to Little Treasures Park including the resurfacing of the basketball courts and upgrades to the softball fields.

2. That the Mayor and the Township Clerk are hereby authorized to execute any and all documents necessary to complete said application for the grant award.

3. That the governing body recognizes and accepts that the Department may offer a lesser or greater amount and therefore upon receipt of the grant agreement from the New


