RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING PARTICIPATION IN THE OCEAN COUNTY COOPERATIVE CONTRACT SYSTEM FOR PURCHASE OF BATTERIES FROM THE OCEAN COUNTY COOPERATIVE UNDER CONTRACT NUMBER B2024-138

WHEREAS, the County of Ocean (hereinafter "County") acts as lead agency in a county cooperative contract purchasing system for Batteries for Various Equipment, Contract number B2024-138, pursuant to N.J.A.C. 5:34-7 et seq.; and

WHEREAS, under this system, the County solicited competitive bids for batteries for various equipment to be purchased, allowing local contracting units within the county to purchase under the terms and conditions of selected contracts awarded by the County without the necessity of securing formal bids; and

WHEREAS, the County has authorized purchasing through the cooperative from Batteries Plus -1071 (Identifier No. CK-02-OC) and East Coast Battery of NJ, LLC (Identifier No. CK-02-OC); and

WHEREAS, the Township desires to participate in the Ocean County Cooperative Contract System and to purchase batteries through the Ocean County Cooperative under Contract Number B2024-138 from Batteries Plus -1071 (Identifier No. CK-02-OC) and East Coast Battery of NJ, LLC (Identifier No. CK-02-OC).

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body hereby authorizes participation in the Ocean County Cooperative Contract System under Contract number B2024-138.
2. That the Township Qualified Purchasing Agent and/or Township Chief Financial Officer are authorized to enter into agreements through the Ocean County Cooperative under Contract Number B2024-138 to

purchase batteries from Batteries Plus -1071 (Identifier No. CK-02-OC) and East Coast Battery of NJ, LLC (Identifier No. CK-02-OC).

3. That the agreement shall be an open-ended contract with funds being encumbered contingent upon the availability of funds in the budget year. No services shall be rendered under the contract until the Chief Financial Officer has certified the availability of funds for such services.
4. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer, Qualified Purchasing Agent, Batteries Plus-1071, East Coast Battery of NJ, LLC and the County of Ocean.
