## SECOND PUBLIC HEARING 2025 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

Township Engineer Jason Worth reported today is the second of the public hearings for the 2025 Community Development Block Grant Program. He explained that the grant program is federally funded from the US Department of Housing and Urban Development, administered through the County of Ocean. He stated funding is based off population for municipalities in the county is provided on a two year cycle, 2023 being the last time the Township participated and 2025 being Little Egg Harbor's new cycle. He stated the grants range from the \$30,000 or \$35,000 and the program is meant to benefit low to moderate income residents. He stated the application is due tomorrow. He recommended submitting an application for Storm Drainage Improvements to Atlantis Blvd in the amount of \$60,000 to offset the funds and any future projects.
