12. TOWNSHIP ENGINEER COMMENTS

Township Engineer, Jason Worth reported the township received a grant through the National Fitness Campaign for a new fitness court and all the equipment has been received and being stored indoors at the public works yard. In addition, he stated the concrete pad was poured last fall where the fitness equipment will be installed and the quotes have been received for the installation. He stated once the weather gets to 50 degrees or higher the equipment will be installed. He stated Tuckerton Borough will be replacing the sanitary sewer main on Daddy Tucker Drive through the state I Banc and are coming close to getting approval to go out to bid. He stated construction for Drainage Improvements have begun and the road will be paved once they are complete. He stated design plans have wrapped up for Leitz Blvd, plans and specs are being sent tomorrow for the NJDOT for review and once we receive the ok, the town will go out for bid. Lastly, he stated a meeting has been scheduled on March 6 with the Ocean County Engineer to discuss township/county projects.

Mr. Edmunds of Center Street spoke regarding a much needed coastal evacuation route in Mystic Island. He also spoke regarding Ordinance 2025-01 needing a three way stop sign on Jefferson Lane and traffic control on Center Street. He is also requesting a R-400 zone in town to eliminate additional traffic and flow throughout the township.

Mr. Paradello, President of the Board of Trustees Four Seasons Sea Oaks HOA, stated Ocean County Natural Lands Trust is looking to acquire the Mancini property as Open Space and the owner is looking to sell it to them. He stated how this came about is that NJDEP found endangered species on the property and the residents of Sea Oaks is looking to preserve the land. He further strongly urged the Township Committee to consider preserving the property and allowing the County to purchase it for open space.

Ms. May of Augusta Drive spoke regarding the Mancini Property urging the Committee to allow the Ocean County Natural Lands Trust to acquire the property. She stated the residents of Sea Oaks have never been in favor of the project in that location. She stated due to the property proposal of a restaurant banquet facility with late hours, a school close by and alcohol consumption possibly during school hours the residents of Sea Oaks felt it was not a good fit. She added the property is in the back yard of several retired Sea Oak residents, as well and the wildlife in that area is also enjoyed by the residents.

Mr. Calissio of West Susquehanna provided the Committee with information regarding a possible rabies exposure in town. He stated people rely on him to rescue wildlife when Animal Control is not available. He stated he received a call of a sick raccoon and when he got to the location, a lady was cradling the sick raccoon. He stated he called the police and the police told him to throw the raccoon in the woods. He stated that is not protocol and the animal should have been tested for rabies or distemper.
