**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW
JERSEY, AUTHORIZING THE GOVERNOR'S COUNCIL
ON ALCOHOLISM AND DRUG ABUSE FISCAL GRANT
CYCLE JULY 2025 – JUNE 2026**

WHEREAS, the Governor's Council on Substance Use Disorder established Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey; and

WHEREAS, The Township Committee of the Township of Little Egg Harbor, County of Ocean, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and

WHEREAS, the Township Committee further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and

WHEREAS, the Township Committee has applied for funding to the Governor's Council on Alcoholism and Drug Abuse through the County of Ocean.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Little Egg Harbor, County of Ocean, State of New Jersey hereby recognizes the following:


1. The Township Committee does hereby authorize submission of a strategic plan for the Eagleswood/Little Egg Harbor/Tuckerton Joint Municipal Alliance grant for fiscal years July 1, 2025 through June 30, 2026 in the amount of:

GCSUD	\$24,393.00
Cash Match	\$ 6,098.25
In-Kind	\$18,294.75

Dear Mayor Pasternak:

The Governor's Council on Substance Use Disorder (GCSUD) has announced its intention to provide a grant to Ocean County to continue funding for the Municipal Alliance Program.

According to the funding formula, the Eagleswood Consortium is eligible to receive approximately \$24,393.00 in GCSUD funds with a Cash Match requirement of \$6,098.25 and an In-Kind requirement of \$18,294.75 for State fiscal year 2026, starting July 1, 2025 through June 30, 2026. All funds are contingent upon receipt of grant funds from the Governor's Council on Substance Use Disorder and approval by the Ocean County Board of Health.

The grant update for FY2026 will require completion of the following forms:

- Form 1A – Strategic Plan for Funding Municipal Alliances
- Form 1B – Municipal Resolution
- Form 1C – Statement of Assurances
- Form 1D – Fiscal Requirements
- Form 3 – Alliance Membership
- Form 5 – Alliance Capacity Assessment Tool
- Form 6 – Alliance Coordination Plan (only if changed from FY26)
- Form 7 – Alliance Action Plan(s) (only if changed from FY26)
- Form 8 – Alliance Budget

The Strategic Plan forms will be emailed to each alliance coordinator. These forms need to be completed electronically. The alliance coordinators will be trained on how to upload them to our online grant management system.

One (1) original copy of the Strategic Plan Grant forms are due to be uploaded to MAGS (Municipal Alliance Grant Management System) by April 29, 2025 by 4:00 PM. Plans received after April 29, 2025 cannot be guaranteed funding.
